Service	Description	Fee
Full Program ADHD Assessment & Optimization	6-week program, 5 visits + QbTest: 60-min comprehensive evaluation, FDA-cleared QbTest, 3 systematic medication trials, extended release trial, maintenance plan, and secure portal messaging.	\$1,099
Transfer Intake Medication Transfer & Onboarding	One-time visit for patients with an established ADHD diagnosis. Includes full medication history review, PDMP check, controlled substance agreement, brief symptom check-in, written care plan summary, and pharmacy setup.	\$325

Follow-Up Visits

Service	Description	Fee
Maintenance Visit	Standard follow-up for medication management, refills, and symptom monitoring. Approximately 25 minutes.	\$175
Extended Follow-Up	For complex medication adjustments, co-occurring conditions, or situations requiring additional time. Approximately 40 minutes.	\$225

Additional Services

Service	Description	Fee
QbTest (standalone)	FDA-cleared computerized test measuring attention, impulsivity, and activity level. Included in the Full Program.	\$200
Medical Records Copy	Copies of records provided upon written request. Fee may be waived at provider discretion.	\$25
Administrative Letter (non-clinical)	Completion of non-clinical administrative letters or forms requested by the patient (e.g., accommodation letters). Note: provider will not write court letters or testify in court.	\$50
